Organizational Information

1. The Conference Venue

The 29th conference will be held at Fairmont Amman Hotel.

2. Reception and Transportation

The delegations participating in the Conference will be received at the airport. The Jordanian Parliamentary Group will ensure the receiving of the participating delegations and will take the necessary arrangements for their departure; to and from the airport, hotel, meeting places, and official events venues.

3. Registration and Information Desk

A Registration and Information Desk shall be placed at the conference venue. The participating delegations are required to register upon arrival in order to get a folder of documents including the personal identity badges, general information, and invitations to attend official events.

4. Entry Procedures to Jordan

The Jordanian Authorities will facilitate the granting of visas for the delegations' members, either from Jordanian Embassies in the concerned countries or at the airport of destination for the delegations whose countries do not have a Jordanian Diplomatic Representation.

5. Distribution of documents

The working documents shall be distributed in the meeting halls to the participating ladies and gentlemen, and they may obtain additional copies from the place assigned for this purpose next to the meeting halls.

6. Photocopying services

For facilitation purpose for the members of the delegations, a space will be provided to photocopy documents during the Conference.

7. Security Precautions

The participating delegations are required to carry their badges during the entire period of the Conference meetings and during the official events.

8. Health Services

The Jordanian Parliamentary Group will ensure a medical unit at the venue of the Conference, to provide first aid services when necessary.

9. Currency Exchange

The currency in use in Jordan is the Jordanian dinar. Delegations can exchange and transfer money at the exchange offices at the hotel and banks.

The currency exchange rates on March, 2019 are as follow:

• US \$ 1: 0.71 JOD • 1 euro: 0.81 JOD

• 1 pound sterling: 0.92 JOD

10. Weather Conditions

Amman city is characterized by a mild climate during the day and relatively cold at night in March.

11. Hotels Accommodation

The Jordanian Parliamentary Group has chosen several hotels for the accommodation of the delegations participating in the Conference, on the basis of preferential rates. Thus, the participating ladies and gentlemen are required to fill out the reservation form and send it directly to the hotel. A copy of this form shall be sent to the secretariat of the Jordanian Parliamentary Group and the General Secretariat of the Arab Inter-Parliamentary Union before 15/02/2019 (for organizational needs).

Participants at this conference shall pay the hotel accommodation fees.
